Activation of the required package or higher is necessary for a free receiver and installation of additional coax outlets, If a lesser package is activated I will be charged for the total retail cost of all receivers, as well as paying full installation costs for any additional coax outlets required. All receivers must be activated with DIRECTV within thirty (30) days of receipt; otherwise I will be responsible for a fee of \$150.00 per receiver. Additional receivers may be returned prior to activation within thirty (30) days to avoid the \$150.00 fee. Installation will be arranged by S&S Broadband on a first come / first served basis. I am aware that DIRECTV requires a one-year commitment, and that all receivers are leased. If I do not return all equipment upon termination of service I am responsible for Non-Return Fees. If I do not complete the one year commitment period I am responsible for a prorated fee of \$240.00. I understand that the contact information on this form will be used to schedule the install and I have verified that the supplied phone number is correct and current.
